**Re: Request under the *Freedom of Information and Protection of Privacy Act***

I am responding to your request of November 13, 2012 under the *Freedom of Information and Protection of Privacy Act* (FOIPP Act). Further to our letter of November 19, 2012, we understand your request to be for:

*Copies of the Asbestos Management Audits used to prepare the latest Immediately Dangerous to Life and Health (IDLH) quarterly report to the Senior Joint Safety & Health Committee (SJSHC).*

*Any correspondence or internal documents, emails, etc. regarding the latest Asbestos Management Audits, inclusive of any correspondence, reports or emails related to the latest IDLH report to the SJSHC.*

Enclosed please find copies of the records responsive to your request.

Some of the records contain information excepted from disclosure under the FOIPP Act. This information was severed so the remaining information could be disclosed. We have also removed some information which is outside the scope of this request because it deals with other subject matters.

The severed information is excepted from disclosure under sections 15, 19, and 22 of the FOIPP Act.

URL information was severed under section 15 because release of the information could harm the security of a computer system. Phone, cellular and facsimile numbers were severed under sections 15 and 19, where release of the information could harm the security of BC Ferries' safety system and could interfere with public safety in the event of an emergency.

Information has been removed under section 22 where disclosure would be an unreasonable invasion of a third party's personal privacy.

An excerpt of the relevant sections is attached. We have noted on the records disclosed to you which section of the FOIPP Act was relied on to sever the information.
