**Re: Freedom of Information and Protection of Privacy Request**

I am responding to your request to British Columbia Ferry Services Inc. (BC Ferries) under the *Freedom of Information and Protection of Privacy Act* (FOIPP Act) for access to the following records:

*The risk assessments undertaken by BC Ferries for the BC Ferries Vacation Centre and BC Ferries drop trailer.*

Enclosed please find copies of the records responsive to your request. One of these records contains information excepted from disclosure under the FOIPP Act. Under section 17 of the FOIPP Act, we have withheld information whose disclosure could reasonably be expected to harm the financial or economic interests of BC Ferries, including information whose disclosure could result in undue loss or gain to a third party, or whose disclosure could reasonably be expected to harm the negotiating position of BC Ferries. We have withheld information under section 21 of the FOIPP Act because its disclosure could harm the business interests of third parties.

This information was severed so the remaining information could be disclosed. An excerpt of the relevant sections is attached.

We have noted on the records disclosed to you which section of the FOIPP Act was relied on to sever the information.
