Re: Freedom of Information and Protection of Privacy Request

British Columbia Ferry Services Inc. received your request for access to information under the *Freedom of Information and Protection of Privacy Act* (the FOIPP Act) on May 15, 2015. Your request is as follows:

I am seeking information about the cost of the cables used for the new Denman cable ferry. Please provide a copy of a document indicating the length of each of the 3 cables needed. Please provide copies of documents indicating the cost per foot or meter (including delivery to Little River and tax) of the 1 5/8 plastic coated cables presently installed.

Further to my letter of June 23, 2015, the third party had 20 days to apply for a review of our decision regarding the disclosure the requested information. The third party did not apply for a review.

Enclosed please find a copy of the record which was produced to respond to your request. As indicated previously, after considering all the relevant factors, we have decided to provide partial access to this record. Under section 17 of the FOIPP Act, we have withheld information whose disclosure would reasonably be expected to harm the financial or economic interests of BC Ferries, including information whose disclosure could result in undue loss or gain to another party, or whose disclosure could reasonably be expected to harm the negotiating position of BC Ferries.

The enclosed record has been marked to show the information removed. An excerpt of the relevant section is also attached.
