Re: Request under the *Freedom of Information and Protection of Privacy Act*

British Columbia Ferry Services Inc. (BC Ferries) received your request for access to records under the *Freedom of Information and Protection of Privacy Act* (the FOIPP Act) on December 21, 2016.

Further to our telephone conversation of December 22, 2016, your revised request is as follows:

1. *RFP 05-07-2016 Overnight Cleaning Routes 1 and 2*
 - a) *the names of the companies who submitted proposals; and*
 - b) *the company who was awarded the contract and the value of the contract.*

2. *RFP 05-02-2016 Shipboard Cleaning*
 - a) *the names of the companies who submitted proposals; and*
 - b) *the company who was awarded the contract and the value of the contract.*

By letters dated January 5, 2017 and February 3, 2017, we responded to items 1b and 2b of your request. Accordingly, this response applies to items only to items 1a and 2a of your request.

The record which was produced to respond to items 1a and 2a was sent for consultation to third parties. Further to our letter of March 9, 2017, the third parties had 20 business days to apply for a review of our decision regarding disclosure of the record. As the third parties did not apply for a review, enclosed please find a copy of the record.
